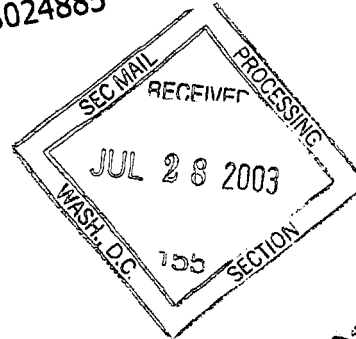

FIRST STAGE OF US DEBT BUSINESSES SALE COMPLETED

Lend Lease Corporation Limited ("Lend Lease") today announced that it has completed the first stage of its previously announced sale of several of its US real estate debt businesses to GMAC Commercial Mortgage Corporation. Lend Lease received an amount of US\$86.5 million (A\$131 million) in respect of the first stage closing. In addition, Lend Lease received approximately US\$49.2 million (approximately A\$74.5 million) for outstanding servicing advances.

The businesses subject to the sale include CapMark Services, the Debt Advisory Group, which includes Program Lending, and the North American Asset Management (distressed debt) business.
