

E. Each Filer designates and appoints Evergreen Corporate Services Inc., 33713 - 9th Avenue South, Federal Way, Washington 98003-6762, telephone number (253) 874-2949, as the agent of the Filer upon whom may be served any process, pleadings, subpoenas, or other papers in

- (b) any civil suit or action brought against the Filer or to which the Filer has been joined as defendant or respondent, in any appropriate court in any place subject to the jurisdiction of any state or of the United States or of any of its territories or possessions or of the District of Columbia, where the investigation, proceeding or cause of action arises out of




