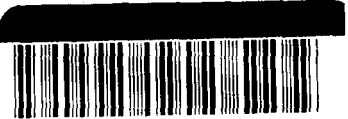

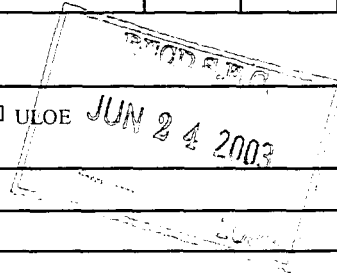



Note 1

The offering pursuant to this Form D (the "Offering") consists of up to 222,444 Class A Membership Units, representing limited liability company interests, at \$4.50 per unit or \$1,000,998 of Class A Membership Units in the aggregate (the "Offering").

Note 2

John W. Heron is a promoter, beneficial owner and one of two initial managers of the Issuer, and also holds the title of Chairman and Chief Executive Officer. Julie A. Plati is a promoter and one of two initial managers of the Issuer, and also holds the title of President and Chief Operating Officer. Mr. Heron and Ms. Plati are both principals of Heron & Company, LLC, a Delaware limited liability company which is a promoter of the Issuer and the beneficial owner of 100% of the Issuer's Class B Units. Dan Robertson is a beneficial owner and holds the title of Vice President-Finance of the Issuer.
