**Pursuant to the terms of the limited partnership agreement of Capital Resource Partners, V, L.P. (the "Partnership"), through the quarter ending December 31, 2008 CRP Partners V, L.L.C. is paid on a quarterly basis a management fee equal to management fee percentage (the "Percentage") multiplied by the aggregate value of the subscriptions to the Partnership commencing in the quarter beginning March 31, 2009, or, upon the satisfaction of certain conditions, this management fee is reduced to an amount equal to the Percentage multiplied by the cost basis of the Partnership's investments that have not been disposed of, distributed or written off for tax purposes. The Percentage is equal to the quotient resulting from (A) divided by (B) where (A) equals the aggregate sum resulting from the following formula applied to the subscriptions of each of the partners: (x) if a partner's subscription is less than or equal to thirty million dollars (\$30,000,000), an amount equal to 0.004375 multiplied by such Partner's Subscription; and (y) if a partner's

subscription is greater than thirty million dollars (\$30,000,000), an amount equal to the sum of (I) \$131,250 (being the product of 0.004375 multiplied by thirty million dollars (\$30,000,000)) plus (II) the product of 0.00225 multiplied by the amount by which such partner's subscription exceeds thirty million dollars (\$30,000,000); and (B) equals the aggregate subscriptions of the partners during such quarter.
