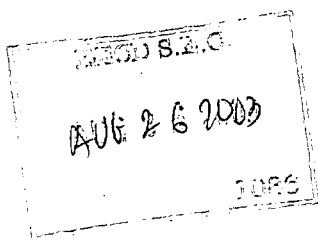

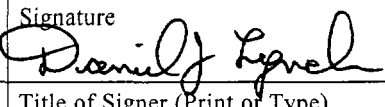

(FOOTNOTES FOR PAGES FOUR AND FIVE)

- (1) The commercial paper notes will be continuously offered with an anticipated maximum amount outstanding of \$600 million. The term of the program is indefinite. As of the date of this amendment, \$186 million in commercial paper is outstanding.
- (2) Total number of investors since the commencement of this commercial paper program.
- (3) Sales commissions will vary and currently average about 5 basis points of the amount outstanding.
- (4) Because this is a continuous offering, the adjusted gross proceeds will vary depending on the amount of commercial paper offered.
- (5) Uses of the proceeds to date are estimates because the Company has various sources of funds. The Company anticipates that future proceeds will be used primarily to repay short-term debt, for business acquisitions, for stock repurchases and for working capital. Because of the indefinite life of the program, uses of the proceeds may vary.
