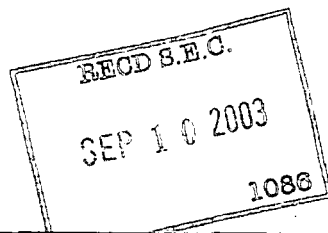

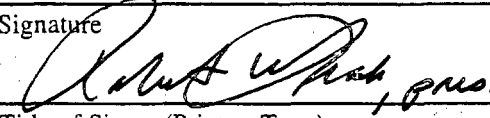

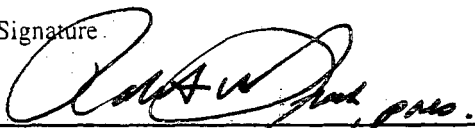

⁵ The purchase price of the Choked Rite - Fixed Rite equipment currently owned by Automotive Collision Equipment, Inc. is being sold to the Limited Partnership for a cost of \$450,000. \$250,000 of the purchase price will be paid from this offering. The remaining \$200,000 shall be evidenced by a promissory note from the Limited Partnership to Automotive Collision Equipment, Inc. amortized for a period of five (5) years and bearing interest at the rate of five percent (5%). Payments to begin within twelve (12) months of the Limited Partnership being established.

⁶ Includes legal, accounting and other offering expenses in connection with the organization and formation of the Company.
