Supplemental Responses to Form D of AHL Services, Inc.

Item C.1.

On August 21, 2003, AHL Services, Inc. (the "Company") issued (i) 58,203,310 shares of its preferred stock (consisting of 10,000,000 shares of Series A preferred stock, 45,953,310 shares of Series B preferred stock, and 2,250,000 shares of Series C preferred stock) and (ii) 588,555 shares of its common stock (collectively, the "Shares") in connection with the closing of the transactions contemplated by the Agreement and Plan of Merger, dated March 28, 2003 by and among Huevos Holdings, Inc., the Company, Frank A. Argenbright, Jr., Kathleen B. Argenbright, Argenbright Partners, L.P., Francis A. Argenbright, Jr. c/r/t, A. Clayton Perfall and Caledonia Investments plc (the "Merger Agreement"). On August 21, 2003, the Company also issued convertible securities consisting of warrants to purchase 526,316, 2,687,328 and 30,977 shares of its Series A preferred stock, Series B preferred stock and common stock, respectively (collectively, the "Warrants") and a convertible bridge note, principal amount \$8,000,000. 38,208,744 Shares were issued in exchange for outstanding securities of the Company, and 20,583,121 Shares were purchased for cash at a price of \$1.00 per Share. The Warrants were issued to a financial institution as consideration for entering into certain financing arrangements related to the transactions contemplated by the Merger Agreement. Dollar amounts throughout this Form D that include Shares issued in exchange and not for cash and the Warrants assume a purchase price of \$1.00 per share for each such Share and Warrant.
