

<sup>1</sup> Consists of convertible bridge notes in the aggregate principal amount of \$425,000, of which \$75,000 is mandatorily convertible into shares of Series A-2 upon the Company executing contracts with an aggregate value of at least \$2,000,000, and of which \$350,000 is convertible into Series A-2 at the option of the note holders. All convertible notes are convertible into a number of shares of Series A-2 equal to the amounts outstanding under each note divided by \$0.358.


