

ATTACHMENT A

Prior Conviction and Securities Law Violations of Sheldon Kraft, the Company's CEO: In December 1997, before the United States District Court of Virginia, Sheldon Kraft, the CEO of Stock News Now and its founder/promoter pled guilty to criminal information charging him with conspiring to commit securities fraud and money laundering and willful failure to file his tax returns. In April 1998, as a result of his guilty plea, Mr. Kraft was sentenced to six months home confinement and three years' probation. Based upon events giving rise to his guilty plea, in 1998, Mr. Kraft also consented to an injunction entered by the United States District Court for the District of Columbia, on an action commenced by the Securities and Exchange Commission ("SEC"), from violating provisions of the registration and anti-fraud provisions of the federal securities laws and was ordered to disgorge approximately \$3,200,000. Contemporaneously, Mr. Kraft consented to the SEC's order barring him from association with any broker, dealer, municipal securities dealer, investment advisor or investment company and from participating in any "penny stock" offering.
