



Footnote to Part C - Question 5

Salaries and Fees

Issuer will pay to its investment manager, a management fee (the "*Management Fee*") equal to 0.125% of the aggregate value of the capital accounts of all members of Issuer at the end of each calendar quarter. The Management Fee is payable quarterly in arrears within 45 days of the applicable quarter end.

In addition, Issuer will pay to its investment manager, an annual performance fee equal to 25% of Issuer's outperformance (if any) of the applicable benchmark index.
