



Sterling Financial Corporation entered into an Agreement and Plan of Reorganization with Church Capital Management, Inc. and Bainbridge Securities Inc. dated September 30, 2003, whereby Sterling will issue an aggregate of \$13.2 million in cash and 480,000 shares of Sterling common stock, valued at \$22.50 per share, in exchange for all of the outstanding shares of Church Capital and Bainbridge as follows:

On October 15, 2003, Sterling shall issue shares of common stock to the following individuals and in the following amounts:
