





SCHEDULE A

TERMS OF OFFERING

The issuer, Cash Technologies, Inc., is making an offer to holders of its outstanding notes to exchange their notes for common stock. As of September 30, 2003, the amount of interest and principal outstanding on the notes was \$3,855,741. The note holders also own common stock purchase warrants. Under the terms of the offer:

- all principal and accrued interest on the Notes would be converted into Common Stock of the Company at a conversion price of \$2.50 per share;
- if the Series B Warrants are exercised before November 14, 2003, the exercise price of all the Series B Warrants would be reduced to \$0.65 per share;
- if the Series B Warrants are not exercised before November 14, 2003, the exercise price would be permanently reduced to \$2.00 per share.

The issuer will not receive any cash proceeds from the conversion of notes. If all of the warrants are exercised base upon a price of \$.65 per share, the issuer will receive an aggregate of \$ 276,185.

All responses on this Form D assume that the warrants will be exercised in full at \$.65 per share.

The offering is being conducted so as to comply with Section 506 of Regulation D and/or Section (42) of the Securities Act of 1933.
