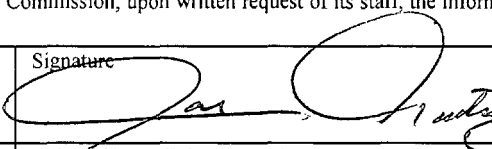

Sorrento Networks Corporation ("Sorrento") issued 1,374,194 shares of common stock, par value \$.001 per share (the "Sorrento Stock") and warrants to purchase an aggregate of 400,000 shares of Common Stock (the "Sorrento Warrants"), to certain holders of the Series A-1 Preferred Stock of LuxN, Inc., a Delaware corporation ("LuxN"), upon consummation of the merger of Lambda Acquisition Corp., a Delaware corporation and wholly-owned subsidiary of Sorrento ("Merger Sub") with and into LuxN pursuant to Agreement and Plan of Merger by and between Sorrento and LuxN (the "Acquisition").

The Acquisition was consummated on August 8, 2003 (the "Closing"). In connection with the Closing, (a) Merger Sub merged with and into LuxN and (b) Sorrento issued the Sorrento Stock and Sorrento Warrants to certain holders of LuxN Series A-1 Preferred Stock. Upon receipt of shareholder approval, an additional 505,153 shares of Sorrento Common Stock will be issued to such shareholders. The aggregate offering price shown in response to Item C.1 represents Sorrento Stock issued in connection with the Acquisition based upon a price of \$3.05 per share of Sorrento Stock.

For purposes of this Form D, we have not ascribed a value to the warrants. Such warrants are exercisable at a price per share of \$3.05 and will be distributed pro rata to the holders of LuxN Series A-1 Preferred Stock.

The maximum number of shares of Sorrento Stock to be issued in connection with the Acquisition will be 1,879,347 and the total number of Sorrento Warrants in connection with the Acquisition will be 400,000.
