





## EXHIBIT A

A total of 32,142,857 units (the "Units") of the Issuer were sold at a price of \$0.214 per Unit. Each Unit is comprised of one Class "A" Common Voting Share (a "Common Share") in the capital of the Issuer and one half of a transferable warrant with each whole warrant entitling the holder to purchase one Common Share at a price of \$0.268 per Common Share until October 23, 2006 (a "Series "A" Warrant").

A total of 8,715,714 Units were sold to four purchasers in the U.S. for an aggregate amount of \$1,864,893.72.

The exchange rate used to calculate the amounts in this Form from Canadian dollars to U.S. dollars is 0.7642 (1.3086), being the exchange rate quoted by the Bank of Canada on October 23, 2003, the closing date of the private placement.

The private placement offering was effected inside the United States pursuant to Regulation D, and outside of the U.S. pursuant to Regulation S.
