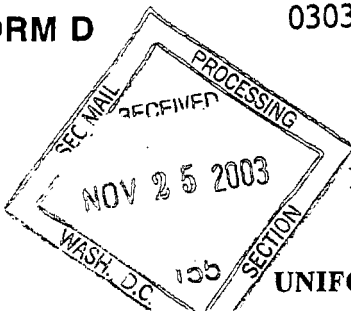

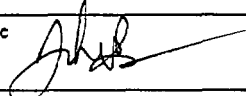

* The general partner and its assignees will receive a quarterly cash fee in an amount equal to .025% of partner capital account balances and a quarterly incentive profit allocation equal to 50% of the net profit in excess of the S&P 500 return and 15% of the amount saved if S&P 500 declines. The Issuer will also reimburse the general partner and its affiliates for approximately \$30,000 of organizational and initial offering expenses.
