



Exhibit A

The Offering consists of 11 Units of securities of Interchange Corporation. Each Unit consists of (i) an 8% secured convertible debenture in the principal amount of \$25,000 and (ii) warrants to purchase 5,000 of the Company's Common shares at an exercise price of \$3.75 per share. The debentures are convertible into shares of Common Stock ("Conversion Share(s)") at an initial conversion rate of one Conversion Share for every \$3.35 of principal amount of debenture so converted, subject to adjustment. The Units are being offered on a "best efforts" basis. The subscription price is \$25,000 per Unit and the Offering is being made only to "accredited investors" as defined under Rule 501 of the Regulation D. The Offering is being conducted pursuant to Section 4(2) of the Securities Act of 1933, as amended, and Regulation D, promulgated thereunder, through GunnAllen Financial, Inc., as placement agent.
