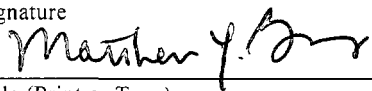

Addendum to Form D Notice of Sale

The Company desires to encourage the interest of certain key employees in its prosperity by encouraging them to become shareholders. The offering will be made only to seven such key employees.
