

Exhibit "A"

Imperial Metals Corporation ("Imperial") sold 2,353,000 units (the "Units") in the offering at the price of CDN\$4.25 per Unit. Each Unit was comprised of one common share in the capital of Imperial and one-half of one non-transferable share purchase warrant. Each whole warrant entitles the holder to purchase one additional common share in the capital of Imperial at the price of CDN\$5.50 for two years.

Of these Units, 62,000 Units were purchased by residents of New York and 271,000 Units were purchased by residents of California, having a total value of approximately US\$1,086,731.

The offering was effected in the United States pursuant to Regulation D and outside of the United States pursuant to Regulation S.
