



<sup>2</sup> The Issuer will pay its administrator a quarterly administration fee at a rate of 0.40% per annum of the Net Assets of the Issuer, calculated and accrued monthly (before deduction of the administration fee and any distributions). The Issuer will pay all of its organizational and offering expenses, including, but not limited to, the costs of preparing, printing and distributing the offering memorandum, supplements and sales material, and expenses incurred in connection with negotiating agreements with the administrator and other third parties. The Issuer will pay other ongoing operating expenses, including, but not limited to, out-of-pocket expenses incurred by its general partner and administrator; taxes, annual audit expenses, accounting expenses, annual government fees, legal expenses, charges of third parties retained by the administrator to perform certain administrative services with respect to the Issuer, the costs and expenses of meetings of the Issuer's board of advisors and limited partners, fees of the members of the board of advisors (\$10,000 per annum for those independent of Citigroup), and the costs of printing and mailing quarterly and annual reports and any extraordinary expenses. The Issuer will pay its general partner an annual fee of \$11,000 for the first fiscal year of the Issuer, and \$10,000 per annum thereafter. Such fees and expenses cannot be quantified at present.
