This Form D relates to (i) the sale and issuance of Series A Voting Convertible Preferred Stock (the "Series A Stock"), and the issuance of Common Stock upon conversion of the Series A Stock, and (ii) the issuance of Series A Stock Warrants (the "Warrants"), and the issuance of Series A Stock upon the exercise of the Warrants. The Warrants will be issued to the placement agents for a nominal price. There is no separate consideration for the conversion of the Series A Stock into Common Stock. Of the securities offered, \$1,437,000 of Series A Stock were sold at the initial closing. It is contemplated that additional shares of Series A Stock will be sold in one or more subsequent closings. The amount reported under "aggregate offering price" represents the aggregate offering price of the Series A Stock and the exercise price of the Warrants. The "Adjusted Gross Proceeds" in Section C.4.b. and "Total Payments" in Section C.5 assume that all the securities offered are sold and that the Warrants will be exercised.
