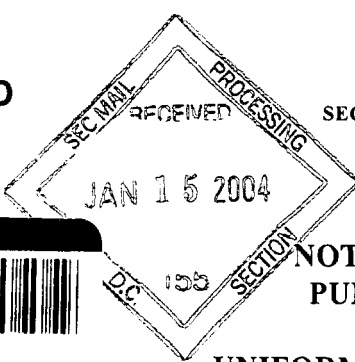

600,000 common shares were issued to Horizon Waste Services, Inc., pursuant to the asset purchase agreement by and among Horizon Waste Services of Arizona, Inc., Horizon Waste Services, Inc., Waste Services of Arizona, Inc. and Capital Environmental resource Inc, dated as of December 31, 2003. The Company purchased assets of Horizon Waste Systems of Arizona, Inc., a solid waste collection business operating in the greater Phoenix, Arizona metropolitan area, with the 600,000 common shares and a cash consideration of \$4.5 mln.
