AMOUNT OF PURCHASES

The amount "purchased" under the 2002 Nonqualified Deferred Compensation Plan (the "NQDC") could not be determined at the time the offering commenced. Under the NQDC, each participant determined the percentage (in ten percent increments) of eligible compensation to be deferred for the plan year (December 1, 2002 to November 30, 2003). Each participant's eligible compensation included, among other components, bonuses and commissions (such bonuses and commissions were in no way related to the offering of participation in the NQDC). The amount of bonuses that might be distributed to participants of the NQDC could not be determined until the plan year ended. Similarly, the amount of commissions that might be earned by participants of the NQDC could not be determined until the plan year ended. Therefore, the amount of compensation to be deferred under the NQDC could not be determined until the end of the plan year.

This Form D reflects the total amount deferred under the plan; no further amounts may be deferred.

The information set forth on the Appendix as to the number of accredited investors and amount purchased is based on the state of residence of each investor, which may differ from the state in which the investor works for FMR Corp. or a subsidiary thereof.
