



B.2. The minimum subscription amount may be increased, decreased or waived at the sole discretion of the General Partner.

B.4. and C.4.a. Credit Suisse Asset Management Securities, Inc. acts as placement agent (the "Placement Agent") for the Issuer. The Placement Agent will be entitled to receive from the Partnership a 1% placement fee with respect to a purchase of Limited Partnership Interests ("Interests") of \$1,000,000 to \$4,999,999 and a 1.5% placement fee with respect to purchases of Interests of \$500,000 to \$1,000,000. The Placement Agent will not receive a placement fee with respect to a purchase of Interests of \$5,000,000 or more. The Placement Agent may, in its sole discretion, waive all or part of the placement fee. The Placement Agent may engage sub-placement agents, including its affiliates, at its own expense.
