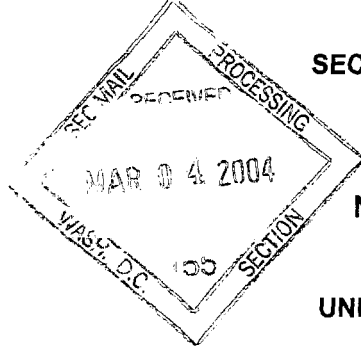

EXHIBIT A

Altair II LP ("Partnership") is a private investment fund formed to pool the assets of its limited partners for the purpose of investing, in alternative investment vehicles, including hedge funds managed by a number of managers selected by the Partnership's investment manager. The Partnership is offering limited partnership interests on a continuous basis to qualified investors. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
