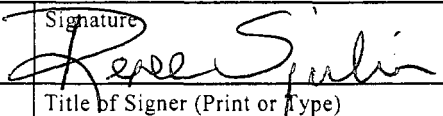

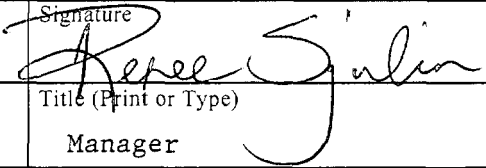

THE EATING ESTABLISHMENT - 168th & DODGE, L.L.C.

Part C - Question 1, 4.a., 4.b. and 5

The offering reported in this Form D is for the sale of 92 membership units (the “Units”) in The Eating Establishment - 168TH & Dodge, L.L.C. (the “Company”) at \$8,500 per Unit for an aggregate offering price of \$782,000 plus 6 Units at \$5,950 per Unit as part of the Company’s Management Incentive Program (additional \$35,700). These Unit sales total \$817,700.

Proceeds from the sale of Units (\$817,700) have been budgeted to cover the costs of building construction, equipment, supplies, signage, architect fees, franchise fees, and other costs and expenses in connection with the Restaurant, along with interest on funds advanced to the Company prior to opening, and all legal, printing, securities exemption filing fees, entity filing fees, copy charges, and related expenses in connection with the offering and in connection with the formation of the Company, and provide for miscellaneous items.
