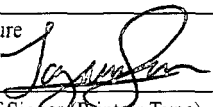

Footnote to Section B: Information About Offering

Item 2: The Member Manager may, at its discretion, waive the minimum investment amount for certain investors.

Item 4: No commissions will be paid from the proceeds of the offering.

Footnote to Section C: Offering Price, Number of Investors, Expenses and Use of Proceeds

Item 1: The aggregate offering price shown is the total amount raised in (i) TCW Energy Fund X – NL, LP (the “Partnership”); (ii) TCW Energy Fund XB – NL, LP (the “XB Partnership”); (iii) TCW Energy Fund XC – NL, LP (the “XC Partnership”) and (iv) TCW Energy Fund XD – NL, LP (the “XD Partnership”), which are co-investment vehicles. The column entitled “Total amount already sold” contains the commitment amounts for the XC Partnership only.

Item 4a: The legal expense amount reported are the aggregate expenses for the Partnership, the XB Partnership, the XC Partnership and the XD Partnership combined.

Item 5: A management fee is payable by the Issuer to TCW Asset Management Company, the Investment Manager as follows: (a) a fee equal to 1.2% of the amount committed by each Participant, payable on each the Initial Contribution Date and (b) commencing 12 months after the First Closing Date, a quarterly fee, payable in arrears, equal to 0.30% of the lower of cost and fair market value of all Loans and Investments held by the Fund, calculated taking proper account of the actual number of days such Loans and Investments were held by the Funds during the quarter.

In addition, the General Partner will be entitled to the distributions of 7% of amounts of income in excess of the 9% Annual Return on Participants’ Unreturned Capital Investment. These distributions will generally be made currently, as income is realized.
