

**ACTUS LEND LEASE SELECTED AS PREFERRED DEVELOPER BY U.S. ARMY FOR
MILITARY HOUSING PROJECT IN NEW YORK**

Lend Lease Corporation Limited ("Lend Lease") today announced that Actus Lend Lease has been selected by the U.S. Army as preferred developer for the development of high quality military homes and communities for Army service members and their families at Fort Drum, New York.

The Fort Drum Residential Communities Initiative (RCI) Project covers the building, renovation, and management of 3,516 homes and multiple community facilities, involving an expenditure of approximately US\$329 million in development scope during the initial 10 year development period. Approximately US\$1.6 billion will be generated in total revenues over the 50 year term of the Project, during which time Actus Lend Lease will have exclusive responsibility for the operation of the Project.

The U.S. Army is expected to award the final contract in late 2004.


