

Exhibit A to the Form D of Sydney Resource Corporation

A total of 5,271,500 units were sold in the offering at a price of \$0.50 CDN (\$0.35 U.S.) per unit for gross proceeds of US\$1,845,025. Each unit consists of one common share and one-half of one non-transferable share purchase warrant, with each whole warrant entitling the holder to purchase one additional common share at a price of \$0.70 CDN (\$0.49 U.S.) for a period of one year.

Of the Units, 900,000 were sold in the United States to three accredited investors for proceeds of US\$315,000.

The offering was effected in the United States pursuant to Regulation D and outside of the United States pursuant to Regulation S.
