

The portion of total management fee for and assessed against each Limited Partner will generally equal 1.50% per annum on capital account balances of \$10,000,000 1.25% per annum on capital account balances on each Limited Partner's next \$10,000,000, and 1.00% per annum on capital account balances on each Limited Partner's capital contribution in excess of \$20,000,000. The issuer pays the Administrator, an affiliate of the General Partner, a fee which shall be accrued and paid weekly, will equal 0.15% per annum of the net Asset Value of the Fund on the last Business Day of each week.
