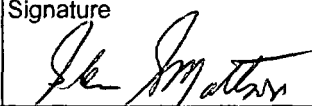

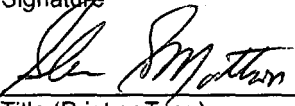

EXHIBIT A

GTK Capital Partners, LP ("Partnership") is a private investment fund formed to pool the investment funds of its investors for the purpose of investing and trading in a variety of securities and financial investments, domestic and foreign, primarily focusing on publicly traded equity securities. The Partnership is offering limited partnership interests on a continuous basis to qualified investors. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
