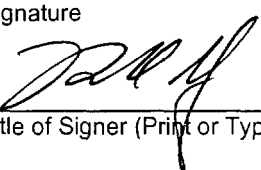

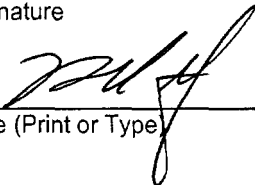

EXHIBIT A

Providence MBS Offshore Fund, Ltd. (the "Fund") is a private investment fund formed to pool the assets of its investors for the purpose of investing and trading in a wide variety of securities and financial instruments, U.S. and non-U.S., primarily focusing on mortgage backed securities and other fixed income securities. The Fund is offering shares to persons and entities outside of the United States and to qualified U.S. investors on a continuous basis. Although there is no maximum or minimum aggregate amount of shares which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares.
