**ANNOUNCEMENT - AUSTRALIAN HIGH COURT DECISION RELATING TO  
LOCAL COUNCIL CHARGES ON CABLES**

---

Singapore Telecommunications Limited ('SingTel') disclosed in its 2003/2004 Half Yearly Financial Report court proceedings in relation to notices issued by local councils seeking to impose charges on aerial and underground cables owned by the SingTel Optus group.

The Full Federal Court of Australia found that the relevant state legislation had the effect of discriminating against carriers and was therefore inconsistent with clause 44(1) of schedule 3 to the Telecommunications Act. The local councils were granted special leave to appeal that decision to the High Court.

The High Court today has found in favour of SingTel Optus.

The New South Wales local councils have previously commenced proceedings in the Federal Court of Australia seeking compensation for overhead and underground cables based on alternative legal arguments which we expect will now proceed. SingTel Optus will vigorously defend these proceedings.
