

YDI Wireless, Inc., a publicly-traded Delaware corporation (“YDI”), is filing the Form D to which this additional material is attached relating to shares of its common stock, par value \$.01 per share, that were issued in connection with YDI’s acquisition of KarlNet, Inc., which was a privately-held Delaware corporation (“KarlNet”).

On May 13, 2004, YDI completed a stock-for-stock acquisition transaction with KarlNet pursuant to a definitive merger agreement dated as of May 13, 2004. Pursuant to the terms of that agreement, YDI formed a subsidiary, KFire Merger Corporation, and KarlNet merged with and into that merger subsidiary, which changed its name to “KarlNet, Inc.” as part of the transaction. As part of the consideration for the acquisition, YDI issued 1,000,000 new shares of its authorized but unissued common stock to the two former stockholders of KarlNet.

On May 13, 2004, the last sale price of YDI’s common stock on the Over-the-Counter Bulletin Board was \$4.20 per share. YDI has used that \$4.20 price in the Form D for purposes of determining eligibility of this issuance as an issuance exempt under Section 4(6) of the Securities Act of 1933, as amended, and determining the aggregate offering price, aggregate amount already sold, and aggregate dollar amount of purchases.

As indicated above, YDI received no cash proceeds from the issuance of these shares.

No fees were paid as commissions for the issuance of the YDI stock in this transaction.

In connection with its acquisition of KarlNet, YDI filed a Current Report on Form 8-K with the Securities and Exchange Commission on May 20, 2004. Reference is made to that filing and the exhibits thereto for more details relating to this transaction.
