AIG Asian Real Estate Partners, L.P. is a Delaware limited partnership (the "Issuer") sponsored by AIG Global Real Estate Investment Corp., a Delaware corporation ("AIG Global Real Estate"), and American International Group, Inc., a Delaware corporation ("AIG"), to make investments in real estate and real estate-related assets and securities in Asia. AIG Asian Real Estate Partners Company, LLC, a Delaware limited liability company (the "General Partner"), is the general partner of the Issuer. The General Partner is a wholly owned subsidiary of AIG Global Real Estate. AIG Global Real Estate is, in turn, a wholly owned subsidiary of AIG. AIG is a publicly listed company whose shares of common stock are listed on the New York Stock Exchange, as well as the stock exchanges in London, Paris, Switzerland and Tokyo.

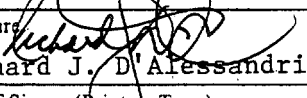

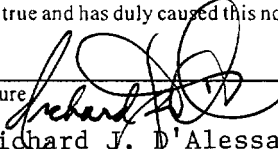
