

¹ The Issuer will pay its own organizational and operating expenses and will be subject to other expenses that K2 Advisors, L.L.C., the Issuer's member manager, has not expressly agreed to pay. In addition, the Issuer will be subject to all investment related expenses including all fees and profit allocations of the managers of the investment vehicles in which K2 Long Short Master Fund, LP, (the "Master Fund") invests. The Issuer will be responsible for its pro rata share of all other fees and expenses incurred by the Master Fund. The Issuer will also pay K2/D&S Management Co., L.L.C., the Issuer's management company, an annual management fee equal to 1.25% of the Issuer's net assets, such fee shall be paid in quarterly installments. The member manager will receive a profit allocation equal to 10% of the amount by which the value of a member's interest on the last business day of a calendar year exceeds by 7% the value of such member's interest on the first business day of such year. None of such fees or expenses can be quantified at present.
