

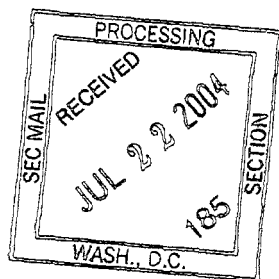

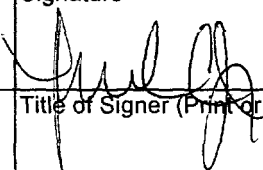

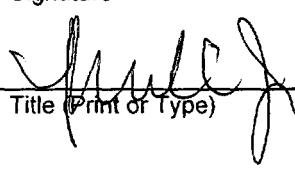

EXHIBIT A

BreakWater Opportunities Fund, Ltd. ("Fund") was formed to pool investment funds of its investors for the purpose of investing and trading in a variety of securities and financial instruments, domestic and foreign, primarily focusing on distressed debt securities of middle market companies. Shares will be offered for sale only to non-U.S. Persons and to a limited number of Permitted U.S. Persons who are also Accredited Investors, Qualified Purchasers and Qualified Clients. Although there is no maximum or minimum aggregate amount of shares of stock which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares of stock.
