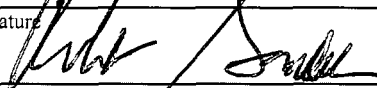

*The Issuer will bear the legal, accounting and administration expenses associated with its organization and the offering of its Limited Partner interests, including any "blue sky" filing fees and expenses and out-of-pocket expenses. Organizational expenses will be amortized over a 60-month period. In addition, the Issuer will bear all costs and expenses directly related to its portfolio investments or prospective investments, such as brokerage commissions, interest on debit balances or borrowings, fees to sub-advisors, consultants and finders, specific expenses incurred in obtaining accounting and research-related systems, research and other information utilized with respect to the Issuer's investment program and any withholding or transfer taxes imposed on the Issuer. Moreover, the Issuer will bear all out-of-pocket costs of its administration, including accounting, audit, administration and legal expenses, costs of any litigation or investigation involving Issuer's activities, and costs associated with reporting and providing information to existing and prospective Limited Partners. The Issuer will pay Cobble Creek Management LP, the Issuer's manager, a management fee at a rate equal to 1.5% per annum of the net asset value of the capital account balance of each Limited Partner. The management fee will be calculated and paid quarterly in advance. The General Partner is entitled to receive a performance allocation equal to 20% or 15% (depending on initial "lock-up" restrictions) of the net profits (subject to adjustments) generated for each Limited Partner's capital account, determined as of each December 31. Such fees and expenses cannot be quantified at present.
