



* The General Partner will pay all costs of establishing the Issuer. The Issuer will pay all expenses in connection with its ongoing operations, including a management fee to the General Partner. The General Partner is entitled to receive a management fee equal to 3.5% of the Net Asset Value of the Issuer, paid in advance on a semi-annual basis. The General Partner will also receive a profit allocation equal to 30% of the net profits of the Issuer. The Issuer will pay an auditor an auditing fee estimated at approximately U.S. \$55,000 per annum. Such expenses, management fee and profit allocation cannot be quantified at present.
