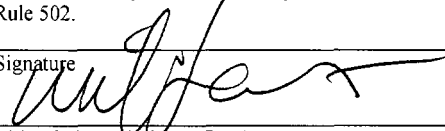
*The fee is 2.0% of total commitments for the first three years of the Fund and 2.0% of capital invested (minus investments sold). Over the approximately 10-year projected life of the Fund (conservatively not taking into account dispositions of investments during the last seven years of the Fund), cumulative management fees could total \$1,580,000 or more. The Manager is also entitled to a “carried interest,” the value of which is impossible to predict at this time.

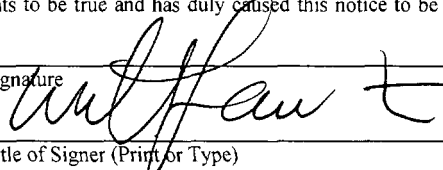
