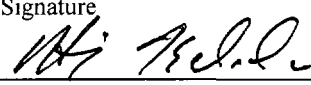

(1) Viral Genetics, Inc. ("Viral") will issue 24,708,560 shares and 24,708,560 warrants in exchange for all of the capital stock of Therapeutic Genetics, Inc. ("TGI"). TGI stock, valued at \$7,418,620, approximates the value of principal and interest owed to TGI from Viral under a certain promissory note, such note being the sole asset of TGI. The "adjusted gross proceeds" represent the sum of \$7,418,620 plus the aggregate exercise price of the warrants of \$9,883,424.
