² As set forth in the Partnership Agreement, the Partnership will pay its own operating expenses (or will reimburse the General Partner to the extent such expenses are incurred by the General Partner). In addition, the Partnership will pay a fixed fee to the General Partner, computed at an annual rate of 1% or 1.5%, as determined by the General Partner in its sole discretion. This fixed fee will be paid quarterly and will be calculated based on the value of the Capital Accounts of the Limited Partners at the beginning of each fiscal quarter and will be deducted from the appropriate Capital Accounts of the Limited Partners. The General Partner will also receive a performance allocation equal to 20% of the appreciation credited to each Limited Partner's Capital Account at the end of each fiscal year. However, no performance allocation will be made in respect of a fiscal year until any net loss previously allocated to the Capital Account of a Limited Partner has been offset by subsequent net profits allocated to the Capital Account of such Limited Partner. Such expenses, fixed fee and performance allocation cannot be quantified at present.
