





Brief Description of Business

The Company operates a transportation business that offers logistic and moving services to customers who require either special handling or specialized equipment to transport their high value products. Because of the high value of the products, the Company provides specially trained drivers and constant monitoring to meet specifications. The services are provided through a network of agents who own the trucks and trailers and are responsible for packing, hauling, storage and distribution of the goods.

Convertible Securities (Including Warrants)

The Company has issued or will issue approximately 10,000 warrants, which are not exercisable until September, 2006. Each warrant entitles a holder to purchase one share of the Company's common stock at \$200.00 per share in September, 2006. The warrants were not sold separately to investors. The Company is acquiring the specialized transportation division of North American Van Lines, Inc. The actual purchase price for the assets will be nominal. The proceeds of this offering will be used for working capital for the division after the acquisition.
