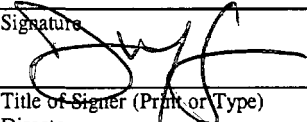

* The Issuer will pay all the costs and expenses associated with the launch of the Issuer, including governmental incorporation charges and professional fees and expenses in connection with the preparation of the Issuer's Confidential Private Placement Memorandum and related agreements, which costs will be amortized over a period of five years. The Issuer bears all other expenses incidental to its operations and business, including without limitation, all transaction costs, including brokerage, banking, sales and purchase commissions and charges and exchange fees, fees and charges of custodians and clearing agents, interest and commitment fees on loans and debit balances, taxes, and other governmental charges and duties, fees of legal advisors and auditors, directors' fees, and costs of printing and distributing offering materials and any reports and notices to Limited Partners. In addition, the Issuer indirectly bears its pro rata share of the costs and expenses of Grinham Diversified Fund (Master) Limited, a Cayman Islands exempted company (the "Master Fund") in which the Issuer invests substantially all of its assets. The Master Fund will pay to Grinham Managed Funds Pty Ltd, the investment manager, with respect to the Issuer, a monthly management fee calculated at an annual rate equal to 1.5% of the month-end net asset value of the Master Fund attributable to the Issuer before reduction for the management fee and a performance fee. The investment manager is entitled to receive a performance fee from the Master Fund calculated at the Issuer's level equal to 20% of the appreciation in the net asset value per equivalent share (shares issued by the Master Fund, in series, which are equivalent and correspond to each series of Units of the Issuer), calculated at the end of each calendar quarter. The foregoing fees and expenses cannot be quantified at present.
