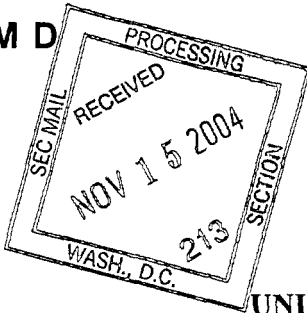

EXHIBIT C.1

Participants program deposit funds in escrow managed by bank trust department, which will invest only in certain enumerated permitted investments. Participants assign income earned on escrow to the issuer in order to support issuer's tax-exempt purposes and the program. Participants are allowed to withdraw funds after three years.

The entire amount of deposits made by participants will be placed in escrow. All costs incurred by the issuer will be paid by the issuer from its own funds.
