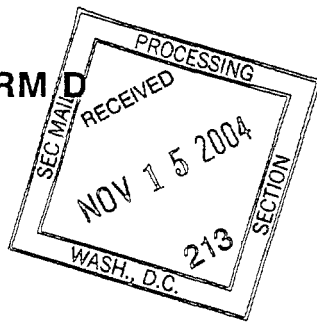

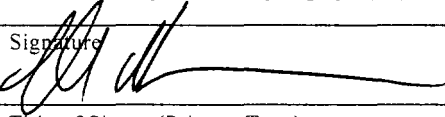

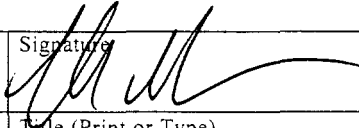

Attachment "A"

Brief Description of Business

The Company operates a transportation business that offers logistic and moving services to customers who require either special handling or specialized equipment to transport their high value products. Because of the high value of the products, the Company provides specially trained drivers and constant monitoring to meet specifications. The services are provided through a network of agents who own the trucks and trailers and are responsible for packing, hauling, storage and distribution of the goods.
