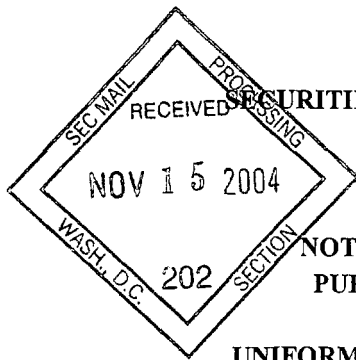

SUPPLEMENT

This transaction involves the issuance of shares of common stock of Dyadic International, Inc. (formerly known as CCP Worldwide, Inc.), a Delaware corporation ("Issuer"), to the former shareholders of Dyadic International (USA), Inc. (formerly known as Dyadic International, Inc.), a Florida corporation ("Dyadic-Florida"), who are entitled to receive such shares pursuant to a merger of Dyadic-Florida with a subsidiary of the Issuer. The shares of the Issuer issued in this transaction are valued at \$3.33 per share for this purpose.
