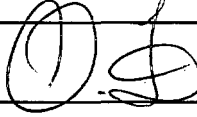

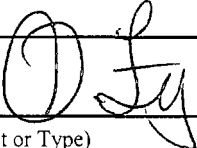

NOTES:

The aggregate face amount of such extendable commercial paper outstanding at any time will not exceed \$5,000,000,000. Due to these circumstances the total number of investors and aggregate amount of purchase is difficult, if not impossible, to ascertain.
