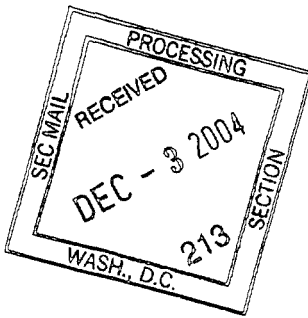

## EXHIBIT A
