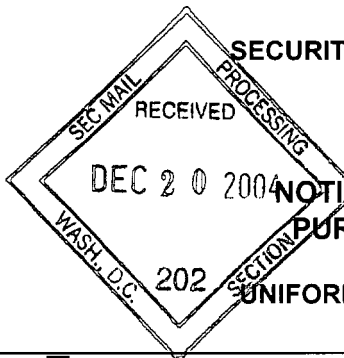

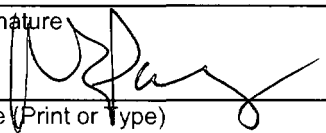

- 1. Each investor that purchased shares of Series B Convertible Preferred Stock also received a warrant to purchase that number of additional shares of Series B Convertible Preferred Stock equal to 50% of the number of shares of Series B Convertible Preferred Stock purchased in the offering at an exercise price equal to 110% of the purchase price paid for the Series B Convertible Preferred Stock.
- 2. \$100,000 of the \$257,400 sales commission was reinvested in the offering. The entity that received the sales commission also received warrants to purchase an aggregate of 953,333 shares of common stock of the issuer at an exercise price of \$0.495 per share.
- 3. Seven of the purchasers in this offering were offshore entities, which invested a total of \$3,358,000.
