NOTE 1.

This offering is a follow-on offering of limited partnership units by Odyssey Operating Partnership, Ltd., a Florida limited partnership and is related to but a separate offering from the offering reported on Form D filed on behalf of Odyssey Operating Partnership, Ltd., on or about April 28, 2004.

NOTE 2.

We may sell limited partnership interest to accredited investors in other states at some point in the future. We currently have no way to determine which states we might sell in or the number of investors for each state other than Florida.
